Discount of entry fee for second and other dogs is agreed only if name of owner is same in all pedigrees.

Every difference (like co-owner) is entry as new application for full amount of entry fee.

Baby, puppy or veteran can not be accepted as 1<sup>st</sup> application from more applications of one owner.

One ticket is free for each application. One catalog is free for 1<sup>st</sup> application from more applications of one owner.

## **General conditions**

- For distinguishing between the 1<sup>st</sup> and 2<sup>nd</sup> deadline payments, the date of the postal stamp on the envelope with the application form or the date of the online or e-mail registration is decisive.
- On the bank transfer, the payer must state the
  - 1. surname of the dog owner.**
  - 2. name of dog**
  - 3. write “CLUB Show Konopiste”**as the payment-reference information, otherwise the payment may not be correctly registered.
- Payments must be made without charge to the payee (payment mode OUR).
- The entry fee includes a free entry for one person per every registered dog. A proof of the payment shall be attached to each application form.
- The organizer reserves the right not to accept a registration without the entry fee payment. In case that the registration is accepted without the entry fee payment and the dog is entered into the catalogue, the exhibitor is bound to pay the entry fee even if he does not come to the show.
- When registering two or more dogs of the same owner, the first dog shall be the one registered to the junior intermediate, open, working or champion/winner class. For dogs registered to baby, puppy or veteran class, fees in the amount set for these classes are payable.
- The show catalogue is included only in the entry fee for the first dog.
- The co-ownership of a dog must be confirmed by a record in the pedigree.
- The fee is refunded only if the application has been rejected.
- Non-participation on the show whatever the reason does not lay ground for reimbursement of the entry fee. In case of the show not taking place from objective reasons (force majeure), the entry fees will be used to cover the expenses.

## **Show conditions**

- The show is accessible to males and females of Cesky Fousek breed, registered in FCI-recognized studbooks, which reach the age required for the entry into the class on the show day.
- By submitting the application form, the exhibitor bindingly accepts all the FCI show regulations, the ČMKU show regulations, the rules and regulations stated in this leaflet, and the instructions of the show committee.
- Each application form must be accompanied by a copy of the pedigree, from which name of the dog, its registration number, name and address of the owner or co-owners and names of dam and sire of the dog can be recognized.
- Judging at the show is conducted in accordance with the FCI and CMKU show regulations; colour varieties are judged according to the regulations of FCI.
- Changes in the exterior of a dog performed by lacquer use, powdering, colouring of the hair and basic treatment by trimming and long-term tying of the dogs on trimming tables are forbidden.
- During the show, the owners shall ensure that there are no injuries of dogs or persons. Free running of the dogs within the show grounds is forbidden.
- The organizer of the show is not responsible for any damage caused by a dog or an exhibitor, nor for a death or a loss of a dog.
- By submitting the application form, the exhibitor agrees with publishing of his address in the show catalogue.
- Incorrect inclusion of the exhibited individual in a ring or class must be dealt with by the exhibitor in the exhibition office until the circular assessment begins.

Classes:
- The division into the classes is in accordance with the Show Regulations of ČMKU and is shown in the application form.
- To enter a dog into the working class, the application form must be accompanied with a copy of the FCI compulsory certificate.
- To enter a dog into the winner class, one of the following titles must have been confirmed by the entry deadline: International Beauty Champion, National Beauty Champion; and a copy of the title certificate must be enclosed to the application form, individuals with title National winner, Club winner, winner of Special show, European winner, World winner. These titles must be found in completion of adult dogs.
- In the individual classes, first four dogs having obtained the qualification excellent or very good are placed.
- The colour varieties of Cesky Fousek are judged separately in compliance with the FCI provisions

The admission of the dog to the show will be confirmed in writing at latest ten days before the show.

If the owner does not receive the confirmation in time, he should check the entry by e-mail or phone.

### **To enter, the following materials must be submitted:**

1. Dog's pedigree
2. Dog's health certificate or Pet passport with proof of vaccination
3. Letter of confirmation of acceptance

### **PARTICIPATION IN THE EXHIBITION WILL BE EXCLUDED**

- Dogs not listed in the catalog. Exceptions are dogs, that are not demonstrably listed in the catalog due to the organizer.
- Dogs sick, suspicion of illness, after injury, females in the second half of pregnancy, nursing and females in heat.
- Dogs owned by persons who have been removed from the right to exhibit.
- Dogs Dangerous - Biting and Aggressive to People and Dogs.

### **Protest:**

1. A protest against any decision made by the judge is not admissible.
2. A protest can be submitted for formal reasons such as violation of show regulation provisions and proposition provisions. The protest must be submitted in written form, against a deposit of 1000 CZK, during the course of the show.
3. If the protest is found to be unjustified, this deposit will be forfeited to the organizer of the show.

### **Veterinary conditions:**

- All the entered dogs must be clinically healthy.
- Dogs must have pet passport or veterinary certificate with valid vaccination against rabies.
- Dogs from EU and third countries must have valid EU Pet Passport and must meet the conditions by the EU Regulation 576/2013.
- In the time during the dog show the owners must supervise / take care of the dogs so that they do not cause any damage to other dogs or humans.

**Age of dog in day of exhibition is the main about registration to the class.**

**Rest of conditions must be full fill in day of application send.**

### **QUALIFICATIONS AND PLACINGS**

The qualifications given by the judges must correspond to the following definitions:

**EXCELLENT** may only be awarded to a dog which comes very close to the ideal standard of the breed, which is presented in excellent condition, displays a harmonious, well-balanced temperament, is of high class and has excellent posture. Its superior characteristics in respect of its breed permit that minor imperfections can be ignored; it must however have the typical features of its sex.

**VERY GOOD** may only be awarded to a dog that possesses the typical features of its breed, which has well-balanced proportions and is in correct condition. A few minor faults may be tolerated. This award can only be granted to a dog that shows class.

**GOOD** is to be awarded to a dog that possesses the main features of its breed. The good points should outweigh the faults so

that the dog can be considered a good representative of its breed.

**SUFFICIENT** should be awarded to a dog which corresponds adequately to its breed, without possessing the generally accepted characteristics or whose physical condition leaves a lot to be desired.

**DISQUALIFIED** must be awarded to a dog which does not correspond to the type required by the breed standard; which shows a behaviour clearly not in line with its standard or which behaves aggressively; which has testicular abnormalities; which has a jaw anomaly; which shows a colour or coat structure that is not according to the breed standard or clearly shows signs of albinism. This qualification shall also be awarded to dogs that correspond so little to a single feature of the breed that their health is threatened. It should furthermore be awarded to dogs that show disqualifying faults in regard to the breed standard. The reason why the dog was rated **DISQUALIFIED** has to be stated in the judge's report.

Dogs that cannot be awarded one of the above qualifications shall be released from the ring with the rating:

**CANNOT BE JUDGED.** This rating is to be given to any dog which does not move, which is lame, which constantly jumps up and down on its handler or tries to get out of the ring, which makes it impossible to assess the gait and the movement or avoids constantly to be examined by the judge and makes it impossible to inspect teeth, anatomy and structure, tail or testicles. This rating is also to be given if traces of operations or treatment can be observed which seem to indicate that the exhibitor wanted to deceive the judge. The same applies if the judge has ample reason to suspect operations that were intended to correct the original condition or feature (e.g.: eyelid, ear or tail). This rating is also to be given in case of "double handling" (i.e. attracting the dog's attention from outside the ring) - which is strictly prohibited. The reason why the dog was rated **CANNOT BE JUDGED** has to be stated in the judge's report.

The four best dogs in each class are placed provided that they have been awarded at least the qualification "VERY GOOD".

### **Classification**

- a) **Baby cl. And puppy cl.**  
Very hopeful, hopeful
- b) **Junior, intermediate, open, working, winner, veteran**  
Excellent, very, good, good, sufficient

### **Titles**

**Winner of Club show** - best male and best female from competition of all V1 (Excellent1) CAC from intermediate, open, work and winner class.

**Junior Winner of Club show** – best male and female from competition of all V1 (Excellent1) CAJC from class of Juniors.

### **Contests:**

**Junior Handling** is judged in two categories: I. cat. – 9 to 13 years, II. cat. – 13 to 17 years. The handler must show a dog that is entered in a studbook recognized by the FCI. A dog of a junior handler does not need to be exhibited at the show, but the breed must have been shown on that day. The presentation of the dog is assessed, its quality is not decisive. The handler must reach the respective age on the show day.

**Best Couple** – a male and a female of the same breed and variety, both having been presented at the show, and owned or co-owned by the same person(s). The co-ownership must be confirmed by a record in the pedigree.

**Best Kennel** – at minimum three individuals of the same breed and variety, which have been judged at the show, which come from the same kennel and which have at least two different fathers or mothers.
